Further to the Order passed this day at 3p.m, the Assistant Secretary of COMED-K has expressed a further practical difficulty in so far as the allotment of seats is concerned. In that, on account of candidates who have already accepted allotment at the Second Round if permitted to participate in the extended Second Round and if that candidate should be selected to a college of his choice, in that event of the student opting to join that college, the seat that he had already been allotted would fall vacant which cannot be allotted to a lesser meritorious candidate, since the software programme under which the allotment process is made does not provide for a roll over process and therefore,

such seats will necessarily have to be surrendered to the Management and has sought clarity in this regard.

This Committee makes it clear that the allotment of seats shall be purely on the basis of merit and if at the extended Second Round on participation of candidates who had already been allotted a seat, if they choose to opt for a better institution on being allotted a seat therein, the seat that falls vacant should necessarily be allotted to a lesser meritorious candidate and cannot be surrendered to the management. If the system does not provide for such a facility of allotment as suggested, the system must be brought in line to facilitate the same and if any further time is required to enable the system to make such correction, the selection and admission made shall be subject to such rectified allotment upon the system being made complaint for such purpose.

Accordingly, time is granted till 5th August 2017 for the COMED-K to carry out this exercise . However it shall be deemed that the admission process has been completed by 30th July 2017.

In view of the above clarification the seats vacated by those who are allotted a better institution shall be reserved and withheld for allotment to the lesser meritorious candidates and shall not be surrendered to the management.
