Sub:- Refund of fee to the students who surrender seats of under graduate courses to Karnataka Examination Authority for 2011-12

REAMBLE:


Requests have been received from students who have selected seats under government quota in admission round/casual vacancy round during 2011-12 and surrendered seats to Karnataka Examination Authority for refund of fee. The proposal has been examined. Hence the order.

ORDER NO.ED 220 TEC 2011, Dated 19th September 2011.

Notwithstanding anything contained in Karnataka Selection of Candidates for Admission to Government Seats in Professional Educational Institutions Rules, 2006, Government are pleased to extend the benefit of refund of tuition fee as under:

- 1) The students who are holding two seats either in engineering or medical or dental courses etc., are requested to surrender the seats selected through CET to Karnataka Examination Authority before 28.9.2011 by 5.00 PM. This request is being made in order to help other deserving students and also to ensure that there is no blockage of seat.
- 2) On surrender, the student will be given refund of Rs.13090 or 28090 or 33090 as the case may be after deducting Rs.5000/- which will be retained as 'processing fee'.
- 3) The student must produce a copy of the bank challan and he must give a letter indicating name of college, branch, category, CET rank, which the student desires to surrender.
- 4) On surrender of the seat, the student's name and seat already selected by the student will be cancelled immediately and treated as vacant and the same will be offered in the extended casual round for Medical/Dental, Engineering and Architecture courses which will be held on 29.9.2011, 30.9.2011 and 1.10.2011 respectively.
- 5) After surrender, the student under no circumstances can claim any right to the surrendered seat. Only those students who are desirous of participating in the extended casual vacancy round which will be held on 29.9.2011, 30.9.2011 and 1.10.2011 need not surrender their seats by 28.9.2011. But they shall surrender the seats before their turn in the extended casual round vacancy.
- 6) KEA will not be responsible for obtaining any of the documents where the student may have deposited with the college or refund or adjustment of any fee, if paid to the college from where the student wishes to surrender the seat. This refund has been provided in order to ensure that no student can take more than one seat and ensure that there is no blockage of seat and in order to help deserving students.
- 7) This refund of 'tuition fee' is applicable for admissions made to government seats through CET/KEA for the academic year 2011-12.
