Mop-up round for unfilled Medical and Dental seats - offline seat allotment - 2017

As per the directions of the Government, KEA is inviting fresh applications for allotment of Medical and Dental seats which remained unfilled after completion of second round (including any stray vacancies) seat allotment from the eligible NEET-2017 qualified candidates and who have NOT been allotted any seat through KEA or at All India / DGHS or from any board / agency. Candidates who have been allotted Dental seat through KEA can participate for Medical seat, but not for dental seat again, however those who have been allotted Medical seat are not eligible to participate.

Medical and Dental seats remained unfilled after second round seat allotment is hosted on the KEA Website http://kea.kar.nic.in

NOTE to CANDIDATES who have NOT REGISTERED:

Those who are interested in these seats and not registered already with KEA have to compulsorily apply online from 8.00 p.m. on **22-08-2017** to up to 2.00 pm on **25-08-2017** by selecting the appropriate link on the KEA Website http://kea.kar.nic.in and participate in the process with all the necessary original documents and one set of attested photocopies. Refer UG NEET 2017 brochure hosted on the KEA Website, regarding submission of original documents.

NOTE to CANDIDATES who have REGISTERED but NOT VERIFIED DOCUMENTS

Those who have already registered with KEA but not attended the document verification need not register once again but they have to participate in the Document Verification and Seat Allotment if interested, with all the necessary original documents and one set of attested photocopies. Refer Page 13 to 16 of UG NEET 2017 brochure hosted on the KEA Website, regarding submission of original documents.

NOTE to CANDIDATES who have REGISTERED and VERIFIED DOCUMENTS

Those who have already registered, verified with KEA and not allotted any seat, need not register once again, but they can participate if they are interested along with verification slip issued by KEA.

NOTE to CANDIDATES who have REGISTERED and VERIFIED DOCUMENTS and eligible for Minority seats

Those who have already registered and verified with KEA and not allotted any seat but eligible for Minority Linguistic / Religious seats (10 years of study in Karnataka in case to claim Linguistic / Religious) can also attend with all the necessary original documents along with verification slip issued by KEA. Refer Page 14, 15 and 47 of UG NEET 2017 brochure and hosted on the KEA Website, regarding submission of original documents and formats. The certificates / formats / affidavit has to be in the prescribed format only.

NOTE to CANDIDATES who have REGISTERED and VERIFIED DOCUMENTS and eligible for NRI seats

Those who have already registered and verified with KEA and not allotted any seat but If any candidate is eligible to claim NRI seats then they have to submit the relevant certificates / documents along with verification slip issued by KEA. Refer Page 16 and 48 of UG NEET 2017 brochure hosted on the KEA Website, regarding submission of original documents.

GENERAL INSTRUCTIONS

- 1. In the first instance the unfilled Minority Linguistic / Religious Medical and Dental seats which remained unfilled will be offered only to the respective minority students.
- 2. The candidates have to be present personally for counselling process; no one can represent the candidate under any circumstances.
- 3. The candidates have to compulsorily pay the prescribed fees in the form of demand draft drawn in favour of "The Executive Director, KEA" payable at Bangalore. Candidates can bring multiple demand drafts. Online payment or Cheques or Cash is not allowed. Candidates will not be allowed to select the seats without the demand drafts for the required fees.
- 4. Counselling will be stopped once the seats are exhausted. Therefore candidates / parents are informed to check the availability of seats.
- 5. If any seats gets cancelled / surrendered or become vacant for any reason will be considered for allotment in the respective category only.
- After completion of the seat allotment if any Government reserved seat remains unallotted after exhausting the last rank, then those seats will be converted and offered to eligible candidates as per rules.
- 7. All other instructions / orders issued by Apex Bodies / Government will imply.

The document verification and offline seat allotment will be conducted at KEA, 18th Cross, Malleshwaram, Bangalore, as per the schedule given below.
