NOTIFICATION

Whereas the draft of the following rules further to amend the Karnataka Civil Services (Classification, Control and Appeal) Rules, 1957, was published as required by clause (a), sub-section (2) of section 03 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) in Notification No. DPAR 17 SDE 2007, dated 27.10.2007 in part-IVA (PR No. 1958) of the Karnataka Gazette Extra-ordinary dated 27.10.2007, inviting objections and suggestions from all persons likely to be affected thereby within fifteen days from the date of its publication in the Official Gazette.

Whereas, the said Gazette was made available to the public on 27.10.2007.

And whereas no objections and suggestions have been received in this behalf by the State Government.

Now therefore, in exercise of the powers conferred by sub-section (1) of section 3 read with section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) the Government of Karnataka hereby makes the following rules namely:

RULES

1. Short title and commencement. - (1) These rules may be called the Karnataka Civil Services (Classification, Control and Appeal) (25th Amendment) Rules, 2007.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. **Amendment of Rule 5.**- In the Karnataka Civil Services (Classification, Control and Appeal) Rules, 1957, (hereinafter referred to as the said rules), in rule 5 for sub-rule (3) the following shall be deemed to have been substituted with effect from 1<sup>st</sup> July 2005 namely:-

“3. In the State Civil Services,-

- (a) Group 'A' shall consist of posts carrying the scale of pay of Rs. 14050-350-14400-400-16800-450-19500-525-22650-600-25050 and above.
- (b) Group 'B' shall consist of posts carrying the scale of pay of Rs. 10800-300-12300-350-14400-400-16800-450-19500-525-20025 and above, but below the scale of pay of Rs. 14050-350-14400-400-16800-450-19500-525-22650-600-25050.
- (c) Group 'C' shall consist of posts carrying the scale of pay above the scale of pay of Rs. 4800-100-6000-125-6500-150-7100-175-7275 but below the scale of pay of Rs. 10800-300-12300-350-14400-400-16800-450-19500-525-20025, but other than the posts specified in Schedule-IV, and
- (d) Group 'D' shall consist of posts specified in Schedule-IV and the posts carrying the scale of pay of Rs. 4800-100-6000-125-6500-150-7100-175-7275.

**Explanation:**- For the purposes of this sub-rule, "scale of pay" means the revised scales of pay specified in respect of various posts in the Karnataka Civil Services (Revised Pay) Rules, 2007 and related orders.

3. **Amendment of rule 9.**- In the rule 9 of the said rules, in sub-rule (2),-

- (i) in clause (bb), for the words and figures "not less than Rupees 4700-6400 the words and figures not less than Rupees 24450-31800" and for the words and figures "not more than Rupees 2600-4575", the words and figures "not more than Rupees 15200-25650"

4700-6400" the words and figures "less than Rupees 24450-31800"

- (iii) in clause (bbb-1), for the words and figures "for the pay scale of Rupees 10620-14960" the words and figures "for the pay scale of Rupees 20025-28275".

shall be deemed to have been substituted with effect from 1<sup>st</sup> July 2005.

4. Amendment to Schedule II and III:- In Schedules II and III of the said rules, the Department of Stores and Purchase and entries relating thereto shall be deemed to have been omitted with effect from 16<sup>th</sup> day of January 2004.
