#### Frequently Asked Questions (FAQ's)

1. I am appearing for final year diploma and waiting for result. Can I apply for DCET-2012?

Ans. Yes, you can apply.

2. What is the minimum percentage to appear for Diploma CET-2012 for admission to B.E course?

Ans. Minimum percentage to appear for Diploma CET-2012 for admission to B.E courses for General Merit candidates in their final year diploma in aggregate is 45% and 40% for SC/ST and cat-1.

3. I have done my Diploma in mechanical and having one year two months work experience. Am I eligible for B.E course in evening college?

Ans. No, you are not eligible. For evening colleges minimum two years work experience is a must from this academic year (2012-13).

4. I have done my Diploma in Computer science. Am I eligible for B.E course in Electronics?

Ans. Please refer Schedule-I & Schedule-II in the KEA website under Diploma CET-2012.

5. I am applying for Diploma CET-2012. Where I should fill the application form and where to fill the challen for fees?

Ans. You have to fill the Diploma CET-2012 application form through online on link Diploma CET-2012 provided through KEA website, and fill the challen and pay the amount only in the KEA prescribed banks (SBM & Designated SBH Counters).

6. When to mention CGPA?

Ans. If the candidate's diploma results are based on GRADING SYSTEM, in such cases marks will not be awarded to the candidates. In that case only candidates are required to mention CGPA in their online application.

#### 7. When is the time to upload marks Card?

Ans. If you are applying through online (eg: Diploma CET-2012), then *there is no need to upload your marks* card along with the application. But, you have to enter the correct marks (all the years/semesters as the case may be) in the online application. Marks cards (original) are required to be produced at the time of Document Verification, failing which the candidate will not be allowed to participate in the seat selection process.

### 8. Are GTTC Candidates eligible for Diploma CET-2012?

Ans. GTTC candidates are advised to know their Diploma equivalence (Diploma awarded by Department of Technical Education, Government of Karnataka) from their respective organizations before filling their Diploma CET-2012 online application.

#### 9. Are NTTF Candidates eligible for Diploma CET-2012?

Ans. NTTF candidates are advised to know their Diploma equivalence (Diploma awarded by Department of Technical Education, Government of Karnataka) from their respective organizations before filling their Diploma CET-2012 online application.

# 10. If the Candidate has done his diploma in Trimester, how to enter the marks in the online application?

Ans. Such candidates are advised to select annual scheme and enter the total marks scored/allotted in all the three semesters as a single entry in the online application. Also, such candidates are requested to send a mail with information regarding Trimester Examination System to KEA official mail ID by mentioning their online Application number and DCET ID.

11. For the experienced candidates what he/she should mention in the date of leaving column, if he is currently working in the same organization on date of submitting application form?

Ans. Such candidates are advised to mention the date of submission of the online application as the date of leaving. It will be treated as currently working and such candidates must produce relevant working/experience certificate(s) at the time of document verification failing which they will not be considered for seat selection.

12. I have not received the any message after saving my details in the online filled application. What I have to do?

Ans. Definitely you will get DCET ID & DCET PASSWORD to the e-mail address you have given in the on-line application with in one hour. In case if you are not getting any message in the form DCET ID and DCET PASSWORD with one hour, FIRST you check whether you have saved the information after filling the online application. Otherwise, please contact KEA through help line numbers provided in the brochure.

#### 13. What is the test and syllabus for diploma Candidates applying for B.Arch Course?

Ans. They need to appear for NATA conducted by Architecture Council of India and they have to score at least 40% marks (for all the category candidates). They need not have to appear for Diploma CET-2012 exam/test conducted by KEA on 19-08-2012. But, they need to fill online application without fail to become eligible for admission to B.Arch course.

14. If the Candidate has an arrear/back paper in the current year, and he is clearing arrear/back paper in another year, what year should he mention as completion of Semester?

Ans. The year in which he has completed, but not the year in which he has studied for that particular subject.

#### 15. What to mention in the Income certificate if parents are not working?

Ans. Please enquire with the Secretary of your Gram Panchayat/Officials of NEMMADI KENDRA to get correct information about this.

## 16. I have done mistake while filling up my name in application, can I change once again?

Definitely you can edit your application before clicking on submit button. After entering all the required items, please verify once again, before clicking the submit button. If you have completed all the formalities including uploading of Challan, Photograph & Signature and finally submission after clicking on submit button, then it is not possible for you to edit.

### 17. How to ensure whether the form has been successfully submitted or not?

Ans. You will get the message as "SUCCESSFULLY SUBMITTED" immediately after you click on SUBMIT button for your successful online application submission. Also, try to get the print out of the form which you have submitted online, and verify for your photo, signature and Challan in the printout.

#### 18. What if the eligibility Clause code chosen is wrong?

Ans. If the application is submitted there is no possibility for you to edit your application. If you are just completed only the filling of the application without uploading challan, photo and signature, still you can edit.

#### 19. Whether I can get the detailed fee structure of the colleges from KEA?

Ans. KEA will publish the structure on its website http://kea.kar.nic.in for the information of the candidates as notified by the Government before the commencement of the seat selection process. However candidates have to contact the colleges for details of other fees to be paid by them at the time of admission.

### 20. Whether the fee can be paid in the form of CASH/ CHEQUE during counseling?

Ans. No. Candidates have to bring the fees only in the form of demand draft drawn in favour of "The Executive Director, Karnataka Examinations Authority", payable at Bangalore. Fees will not be accepted in the form of CASH/ CHEQUE and DD's will not be issued at the KEA premises.

## 21. I have done my diploma in Chemical Engineering course, to which B.E course I am eligible?

Ans. For the course eligibility please refer Schedule-I & Schedule-II in the KEA website under Diploma CET-2012.

## 22. As this time there is online filling of Diploma CET application form, how can I get hard copy of brochure?

Ans. Even if you applied through online application you can download the DCET brochure through KEA website under Diploma CET-2012 link.

#### 23. Who is eligible to apply for BE course in EVENING College?

Ans. For Evening college BE course the candidates with a work EXPERIENCE of not less than two years as on 1<sup>st</sup> September 2012 in an establishment is eligible.

#### 24. What is the fee structure for University Colleges for BE courses?

Ans. The fees structure will be notified in our website after getting the Government Order for the Academic year (BEFORE the counseling).

#### 25. Which are the government/University colleges and what is the fee to be paid?

Ans. For the list engineering colleges refer Appendix-I in KEA website. University/Government college/Private college's fee to be paid will be displayed in our website after getting letter from the government for the academic Year 2012-13.

26. I am OBC candidate belongs to Cat-2A and secured 49% (aggregate) in diploma final year Exam, whether I am eligible to appear for Diploma CET-2012 to take admission to B.E course?

Ans. YES, you are eligible.

## 27. Will I get Diploma CET-2012 exam centers outside Bangalore?

Ans. Yes, Diploma CET-2012 Exam centers are located throughout Karnataka.

### 29. I am Gadinadu kannadiga candidate. Can I appear for Diploma CET-2012?
