



NEET-MDS – 2020 Online Registration enabled due to Lowered Percentile

1. Ministry of HFW, GOI, New Delhi, in their public notice No. F.No.V.12025/50/2020-DE dated 03-07-2020, has lowered the qualifying cut-off percentile for NEET-MDS, 2020 for admission to PG Dental Courses.
2. Online registration is enabled to **only for such candidates who become eligible in view of lowered percentile for PG Dental courses.**
3. The academic eligibility criteria as laid down in PGNEET-2020 Information Bulletin and other conditions are hosted on the KEA Website for the information of the candidates. The candidates who have scored more than or equal to the prescribed minimum score in NEET MDS 2020 only are eligible to register for PG Admissions. Please note that SC/ST/OBC eligibility criteria are applicable to native of Karnataka SC/ST/OBC candidates only.
