Recruitment for the Post of Staff Nurse in various Medical Colleges / Institutions

Document verification for B.Sc. Candidates

The candidates who have obtained marks / score 40 and above in the Competitive Examination (irrespective of the claimed respective category) are eligible to participate in the document verification process as per the schedule.

The following Original Documents along with one set of attested Photocopies of all the documents to be submitted by candidates during document verification.

1. Candidate copy of the Admission Ticket of Competitive Examination.
2. Final printout of the Online Application Form.
3. Valid Photo Identity Card.
(PAN Card / Voter ID / Passport / Driving Licence / Aadhar Card / Ration Card)
4. SSLC Marks card or equivalent certificate for proof of date of birth.
5. B.Sc. (Nursing) / GNM marks card of all phases/years issued by the Concerned University as required for the post of recruitment.
6. Qualifying Degree / Diploma Certificate (Provisional Degree / Diploma Certificate) issued by the concerned Board/University.
7. Nursing Council Registration Certificate.
8. Two passport size photographs.

The following documents should be produced, "ONLY if applicable" and only if the claims are made in the online application. (Candidates are not allowed to get the benefit of reservation if reservation claims are not made in the online application)

9. Certificate issued by the Competent Authority for having claimed age relaxation.
10. Experience Certificate issued by the Concerned Authority for in-service candidates for number of years of service rendered and also NOC from the department.
11. Caste Certificate / Caste-Income Certificate.
(For SC/ST in 'Form-D', Category-1 in 'Form-E' and 2A, 2B, 3A, 3B in 'Form-F').
12. Income Certificate (For SC/ST/Category-1 Candidates).
13. 10 Years Study in Rural Area Certificate in Format 1 and 2(Rural Candidates).
14. 10 Years Study in Kannada Medium Certificate (Kannada Medium Candidates) in the prescribed format.
15. Certificate issued by the competent authority for claiming reservation under 371(j)
(Hyderabad-Karnataka Region) (Annexure-A).
16. Ex-Defence Certificate countersigned by Director, Dept. of Sainik Welfare Board, Bangalore.
17. Project Displaced Certificate issued by the Tahasildar of concerned Taluk in the prescribed format.
18. Physically Handicap certificate as per the format and Acknowledgment issued by KEA during Medical examination.

Note:

1. Document verification will be conducted at Karnataka Examinations Authority, 18th Cross, Sampige Road, Malleshwaram, Bangalore – 560 012.
2. The candidate has to be present personally and no one can represent the candidate. Candidate has to attend the document verification only on the notified date as per schedule.
3. Candidates, who fail to submit the relevant certificates at the time of verification, will not be eligible for further process of recruitment.
4. No extension of time will be given to candidates to submit the relevant certificates as per claim.
5. No TA will be paid to candidates to attend the document verification.
