Instructions for Document verification

- Pursuant to the provisional merit list published on the KEA Website <http://kea.kar.nic.in>, KEA will publish the provisional merit list in 1:2 ratio for verification of documents.
- Only those candidates are enlisted in the Document Verification List are here by informed to attend the document verification process as per the schedule which will be hosted on the KEA Website.
- **All the relevant certificates should be obtained as on the last date fixed for receipt of application in the respective notification.**

The following Original Documents along with one set of attested Photocopies of all the documents to be submitted by candidates during document verification.

1. Two recent passport size photographs.
2. Candidate copy of the Admission Ticket of Competitive Examination.
3. Final printout of the Online Application Form.
4. Valid Photo Identity Card.
(PAN Card / Voter ID / Passport / Driving Licence / Aadhar Card / Ration Card)
5. SSLC Marks card or equivalent certificate for proof of date of birth.
6. Degree Marks Cards of all the years / semesters and Degree Certificate (Convocation Certificate) issued by the concerned board / university.
7. Masters Degree marks cards of all the years / semesters and Master Degree Certificate in the relevant subject issued by the concerned Board/University.
8. Certificate for having declared successful in the "National Eligibility Test"
or
Certificate for having declared successful in the "State Level Eligibility Test". Candidates who have qualified in SLET test are eligible only if they have qualified from Karnataka State SLET conducting authority.
or
Ph.D through Course Work and Evaluation Process in the concerned / relevant discipline as per UGC (Minimum standards and procedure for awards of Ph.D Degree) Regulation, 2009, dated 11-07-2009. (UGC regulation is hosted on the KEA Website)

The following documents should be produced, "ONLY if applicable" and only if the claims are made in the online application. (Candidates are not allowed to get the benefit of reservation if reservation claims are not made in the online application)

9. Certificate issued by the Competent Authority in support of their claim for having claimed age relaxation.
10. Experience Certificate issued by the Concerned Authority for in-service candidates for number of years of service rendered and also NOC from the department.

11. Caste Certificate / Caste-Income Certificate.

(For SC/ST in 'Form-D', Category-1 in 'Form-E' and 2A, 2B, 3A, 3B in 'Form-F').

(As per Government Order ಕಿಂವಚ 148 ಬಿಸಿವ 2015 ಬೆಂಗಳೂರು, ದಿನಾಂಕ 04-06-2015, the candidate and his / her father's - mother's who's Gross Annual Income is below Rs.6.00 Lakhs are eligible to claim benefit of reservation under 2A, 2B, 3A and 3B categories. Further the candidates who have married, the spouse income if any, will also be considered for annual income)

NOTE:

- a. The candidates who are already working in Central / State Government / Public Sectors / Joint Sector Undertaking / Limited Companies / Banking Sectors and who are in the pay scale of 21600-40050 and above are not eligible to claim benefit of reservation under 2A, 2B, 3A and 3B. (DPAR Notification No. DPAR 17 SDE 2007 dated 26.12.2007 is hosted on the KEA Website.)
 - b. Such candidates should submit the detailed Pay slip obtained from the head of the organization as on the last date fixed to submit the application to claim rural reservation if they have studied in rural areas from 1st standard to 10th standard if their annual income is below Rs.6.00 Lakhs.
12. 10 Years Study in Rural Area Certificate in Format 1 and 2 (Rural Candidates – Government order is hosted on the KEA Website).
13. 10 Years Study in Kannada Medium Certificate (Kannada Medium Candidates) in the prescribed format.
14. Certificate issued by the competent authority for claiming reservation under 371(j) (Hyderabad-Karnataka Region in Annexure-A).
15. Ex-Defence Certificate countersigned by Director, Dept. of Sainik Welfare Board, Bangalore.
16. Physically Disabled certificate as per the format and Acknowledgment to be issued by KEA during Medical examination.

Note:

1. If the information furnished by the candidates in the application form or any other document/s / certificates submitted by the candidates / parents are found to be false / incorrect / tampered / forged, such candidate's candidature will be disqualified and if he / she selected for any category of post will be cancelled at any point of time and criminal proceedings as per rules will be initiated by the Government against the candidate.
2. Document verification will be conducted at Karnataka Examinations Authority, 18th Cross, Sampige Road, Malleshwaram, Bangalore – 560 012.
3. The candidate has to be present personally and no one can represent the candidate. Candidate has to attend the document verification only on the notified date as per schedule.
4. Candidates, who fail to submit the relevant certificates at the time of verification, will not be eligible for further process of recruitment.
5. No extension of time will be given to candidates to submit the relevant certificates as per claim.
6. No TA will be paid to candidates to attend the document verification.

Candidates who have applied through offline based on the directions of Hon'ble KAT will have to submit the relevant certificates along with the KAT order and their verification is subject to final decision of the KAT order in respective applications and does not confer any right on the candidate for recruitment.
